

## REGULATIONS FOR USING THE NET CLIMBING ROOM

### § 1

1. These Regulations contain supplementary and specific provisions specifying the rules for using the net climbing room located in the swimming pool area separated from the Chochołów Thermal Bath Facility.
2. Net climbing is an integral part of the swimming pool area, and all persons using it are obliged to comply with the provisions of these Regulations and the Regulations for using the swimming pool area.
3. Each User is also obliged to strictly comply with the provisions of the main Regulations of the Facility.
4. In all matters not covered by these Regulations, the other Regulations in force in the Chochołów Thermal Bath Facility shall apply, particularly the provisions of the main Regulations of the Facility.
5. Each person using the net climbing facility must read the content of these Regulations before using it and then comply with its provisions. It is also required to familiarise yourself with the information boards, pictograms and instructions for use available next to the artificial river.

### § 2

1. Children under the age of 13 may use the net climbing facility only under the constant care and supervision of a parent or adult guardian who is obliged to stay in the immediate vicinity of the net climbing facility while the child is using it.
2. Each User using the net climbing does so at their responsibility and risk.
3. When using the net climbing facility, it is necessary to follow the lifeguards' instructions on duty.
4. Exercise extreme caution when stepping onto the net.
5. People using net climbing should keep the necessary distance from other Users.
6. Immediately leave the water zone adjacent to the net after completing the transition.
7. Users using the net climbing are not allowed to create situations that could threaten the health or life of people using the climbing and swimming pool area. In particular, it is prohibited to:
  - people with ailments and/or a history of diseases of the musculoskeletal system, suffering from fear of heights, with limited ability to move independently, with circulatory system disorders, with labyrinth disorders, anxious, under the influence of alcohol or substances that interfere or limit judgement can use the attractions situations or causing unnatural behaviour;
  - changes of direction while travelling the route;
  - staying in the water in the vicinity of the net after losing contact with the rope;
  - bring any objects onto the net and make passages with objects that may cause bodily injury, in particular: glasses, jewellery (watches, rings, bracelets, thongs, chains, earrings, hair ornaments, etc.) and/or swimming equipment ( boards, sleeves and swimming goggles, etc.);
  - disturbing in any way people travelling the route;
  - net dives;
  - climbing the net and jumping into the water;
  - use net climbing if the access is closed with a chain, rope, barrier or in another visible way.

8. In the event of noticing any defects, faults, failures, accidents, or other situations that pose a real threat to other Users or the Service, the Customer is obliged to immediately notify the lifeguard on duty.
9. All persons using the net climbing are obliged to strictly follow and comply with the instructions, commands and sound signals of the lifeguards and employees of the swimming pool area, as well as messages given through loudspeakers.

### **§ 3**

1. In the event of an accident caused by non-compliance with these Regulations, the User bears all responsibility.
2. All persons violating public order or the provisions of these Regulations will be removed from the net climbing area and the swimming pool area.
3. Other basic rules for using the Facility, as well as the rules of liability and obligations of the Customers, are regulated by the Regulations for using the swimming pool area and the main Regulations of the Facility.
