

REGULATIONS FOR USING THE ARTIFICIAL RIVER

§ 1

1. These Regulations contain supplementary and specific provisions specifying the rules for using an artificial river in the swimming pool area separated in the Chochołów Thermal Bath Facility.
2. The artificial river is an integral part of the swimming pool area, and all persons using it are obliged to comply with these Regulations and the Regulations for using the swimming pool area.
3. Each User is also obliged to strictly comply with the provisions of the main Regulations of the Facility.
4. In all matters not covered by these Regulations, the other Regulations in force in the Chochołów Thermal Bath Facility shall apply, particularly the provisions of the main Regulations of the Facility.
5. Each person using the artificial river is obliged to read the content of these Regulations before using it and then comply with its provisions. It is also required to familiarise yourself with the information boards, pictograms and instructions for use available next to the artificial river.

§ 2

1. Technical data of the artificial river:
 - Depth - 1.25 m;
 - Difficulty level - HARD.
2. The ability to use (depending on availability) the artificial river depends on the ability to swim and the Users' general health and physical fitness.
3. An artificial river is a place with an increased risk of accidents (including the risk of bodily injury or injury), even when using a device that has been tested and maintained in accordance with standards and when following the instructions on information boards. Therefore, each User using an artificial river does so at their own risk and responsibility.
4. The thermal baths are not responsible for accidents that occur during the use of the artificial river, caused by non-compliance with the rules of use.

§ 3

1. The artificial river can only be used by Users who can swim independently.
2. Children under 13 can use the artificial river only under the constant care and supervision of a parent or adult guardian.
3. Participants of organised groups, including children and youth of school age, may use the artificial river only in the presence of a group guardian supervising them. A caretaker must be present and supervise the group members at all times in the artificial river casement.
4. When using an artificial river, you must strictly follow the lifeguards' instructions on duty.
5. Users using the artificial river must not create situations that could threaten the health or life of people using the artificial river and the swimming pool area. In particular, it is prohibited to:
 - bring any objects into the gutter of the artificial river and use the artificial river with objects that may cause bodily harm, in particular: glasses, jewellery (watches, rings, bracelets, straps, chains, earrings, hair ornaments) and swimming equipment (boards sleeves, etc.);
 - stopping and standing inside the gutter;

- swimming against the current;
 - underwater diving;
 - enter the gutter of the artificial river outside the designated place;
 - the use of an artificial river in the case of closing the access with a chain, rope, barrier or in another visible way.
6. The swimming position should ensure good visibility of the area in front of the swimmer and prevent the possibility of colliding with other Users. This position should be maintained throughout the swimming.
 7. In the event of noticing any defects, faults, failures, accidents, or other situations that pose a real threat to other Users or the Service, the Customer is obliged to immediately notify the lifeguard on duty.
 8. All persons using the artificial river are obliged to strictly follow and comply with the instructions, commands and sound signals of lifeguards and employees of the swimming pool area, as well as announcements made through loudspeakers.

§ 4

1. In the event of an accident caused by non-compliance with these Regulations, the User bears all responsibility.
2. All persons violating public order or the provisions of these Regulations will be removed from the artificial river, as well as from the swimming pool area.
3. Other basic rules for using the Facility, as well as the rules of liability and obligations of the Customers, are regulated by the Regulations for using the swimming pool area and the main Regulations of the Facility.
