

REGULATIONS FOR USING HOT BATHTUBS

§ 1

1. These Regulations contain supplementary and special provisions specifying the rules for using hot bathtubs located in the swimming pool area separated in the Chochołów Thermal Baths Facility.
2. Individual hot tubs are an integral part of the swimming pool area, and all persons using them are obliged to comply with these Regulations and the Regulations for using the swimming pool area.
3. Each User is also obliged to strictly comply with the provisions of the main Regulations of the Facility.
4. In all matters not covered by these Regulations, the other Regulations in force in the Chochołów Thermal Baths Facility shall apply, particularly the provisions of the main Regulations of the Facility.
5. Each person using the hot tub must read these Regulations before using them and then comply with its provisions. It is also required to read the information boards available within the bathtubs.

§ 2

1. Hot tubs are available to Users authorised to use the swimming pool area in accordance with the rules applicable in this area, taking into account the following reservations.
2. The use of the hot tub is at the User's own risk.
3. People with circulatory, respiratory, neurological and gastric dysfunctions should use the hot tub cautiously and only after medical consultation.
4. Participants of organised groups, including children and youth of school age, may stay in hot tubs only in the presence of a group guardian supervising them.
5. Children under 13 can use the hot tub only under the constant care and supervision of a parent or adult guardian.

§ 3

1. Use extreme caution when getting in and out of the hot tub.
2. The person leaving the hot tub has priority in communication.
3. It is forbidden to cause situations that threaten one's own safety, the safety of other people using the hot tub and the swimming pool area, or that may cause an accident, in particular:
 - entering and exiting the hot tub in a way other than through dedicated stairs/ladders;
 - using the hot tub when the aeration system is turned off;
 - using the hot tub if the access is closed with a chain, rope, barrier or other visible way;
 - pushing people into the hot tub;
 - bringing any objects into the whirlpool tub, it is forbidden to bring and consume drinks or food;
 - staying in a hot tub in a standing position;
 - head and face immersion;
 - pouring water out of the hot tub;
 - sitting on the rim of the whirlpool tub.
4. All persons using hot tubs are obliged to strictly follow and comply with the instructions, commands and sound signals of lifeguards and employees of the swimming pool area, as well as announcements made through loudspeakers.

§ 4

1. In the event of an accident caused by non-compliance with these Regulations, the User bears all responsibility.
2. All persons violating public order or the provisions of these Regulations will be removed from the bathtubs and the pool area.
3. Other basic rules for using the Facility, as well as the rules of liability and obligations of the Customers, are regulated by the Regulations for using the swimming pool area and the main Regulations of the Facility.
