

REGULATIONS FOR USING WATER SLIDES

§ 1

1. These Regulations contain supplementary and specific provisions specifying the rules for using water slides located in the swimming pool area separated in the Chochołów Thermal Baths Complex.
2. Water slides, described in detail later in these Regulations, are an integral part of the swimming pool area, and all persons using them are obliged to comply with both these Regulations and the Regulations for using the swimming pool area.
3. Each User is also obliged to strictly comply with the provisions of the main Regulations of the Facility.
4. In all matters not covered by these Regulations, the other Regulations in force in the Chochołów Thermal Baths Complex shall apply, particularly the provisions of the main Regulations of the Facility.
5. Each person using the slide is obliged to read the content of these Regulations before using it and then comply with its provisions. It is also required to familiarise yourself with the information boards, pictograms and instructions for use available next to each slide.

§ 2

1. The ability to use (depending on availability) individual slides depends - depending on the type of slide - on the User's height, weight, swimming skills and general health and physical fitness.
2. Slides are places with an increased risk of accidents (including the risk of bodily injury or injury), even when using equipment that has been tested and maintained in accordance with standards and when following the instructions on information boards. Therefore, each User using water slides does so at their own risk and responsibility.
3. The Thermal Baths are not responsible for accidents occurring on the water slides, caused by non-compliance with the rules regarding the use of the slides, as well as for the condition of swimwear damaged or worn as a result of using the slides.
4. Guests are required to abide by the weight and height restrictions for each type of slide.
5. The use of the slide by persons whose height or weight does not fall within the limits indicated on the information boards or contrary to the instructions issued by the Staff is prohibited and may result in an accident.

§ 3

1. When using the water slides, you must strictly follow the lifeguards' instructions on duty.
2. Children under 13 may use the slide only under the constant care and supervision of a parent or adult guardian. It is forbidden to leave unsupervised children who cannot swim.
3. Participants of organised groups, including children and youth of school age, may use the water slide only in the presence of a group guardian supervising them. The guardian must be present and constantly supervise the group members on the slide-starting platform.
4. The slides are not intended for people with cardiovascular, respiratory, skeletal, neurological and gastric dysfunctions and those who are particularly sensitive to sudden overloads.

5. The slide down the water slide is single or double, depending on the slide type.
6. Exercise extreme caution when climbing the slides. Right-hand traffic is allowed on the stairs. Running up the stairs is strictly forbidden.
7. Before using the water slides, you should remove glasses, watches, chains, earrings and other similar items that could be damaged and cause injury or cuts to yourself or other Users and lead to damage to the slide. These items can be left in special lockers available to Guests free of charge, located in the swimming pool area.
8. On the slide, it is obligatory to comply with the traffic lights located above the entrance to the downhill pipe, the indications of which mean:
 - green colour - exit allowed;
 - red colour - exit prohibited;Regardless of the above indications, you should ensure that the descent zone is free each time and that a safe descent is possible.
9. It is strictly forbidden to stop during the descent.
10. Only descent with legs in the direction of travel is allowed.
11. After the descent, immediately leave the braking basin in the direction the arrows indicate. Guests who do not leave the exit area immediately will be responsible for any accidents resulting from such action.
12. Users using the slide must not create situations that could threaten the health or life of people using the slide. In particular, it is prohibited to:
 - run up the stairs of the water slide tower, pushing each other on the starting platform and forcing other Users to slide down, pushing people into the downhill chute;
 - use water slides in the event of damage to the traffic lights, water slide gutter or other technical defects;
 - use the slide if the access is closed with a chain, rope, barrier or in another visible way;
 - start the slide when there are other people in the downhill chute or on the slide landing site;
 - slide down in groups;
 - slide down in a position other than the one applicable to a specific type of slide;
 - turn backwards/forwards during the descent;
 - run into the water slide to increase the speed of the descent; jump into the run-up slide chute;
 - use water slides for people after consuming alcohol, drugs, intoxicants or other substances with a similar effect;
 - stop and stand inside the downhill pipe;
 - stop unjustifiably while descending;
 - climb on balustrades, handrails and structural elements;
 - enter the downhill pipe from the side of the end element and climb inside the pipe towards the starting point;
 - stay within the slide landing zone;
 - bring any objects into the downhill chute;
 - slide down with objects that may cause bodily injury, in particular: glasses, jewellery (watches, rings and wedding rings, bracelets, thongs, chains, earrings, hair ornaments, etc.) and swimming equipment (boards, rings, swimming sleeves and swimming goggles, etc.) - these items can be left in special lockers available to Guests free of charge and located in the

swimming pool area; in justified cases, only a lifeguard can recommend the use of sleeves or a vest.

13. After dusk, some sections of the downhill pipes are dark.
14. In the event of noticing (including during the descent) any defects, faults, failures, accidents, or any other situations that pose a real threat to other Users or the Staff, the Customer is obliged to immediately notify the lifeguard on duty.
15. All persons using the slides are obliged to strictly follow and comply with the instructions, commands and sound signals of the lifeguards and employees of the swimming pool area, as well as messages given through loudspeakers.

§ 4

1. The thermal baths have the following water slides:
 - I) SLIDE WITH A TRAP (external slide);
 - II) BLUE SLIDE (external slide);
 - III) GREEN PONTOON SLIDE (external slide);
 - IV) FAMILY SLIDE (indoor slide);
 - V) GUTTER SLIDE (internal slide).
2. Each slide has a different level of difficulty. Each of them has different restrictions and specific instructions regarding the rules of use, detailed below. These instructions should be treated as supplementary to the general instructions listed at the beginning of these Regulations.

ad. I.

SLIDE WITH A TRAP

Slide data:

Length: 61.67 meters

Decrease: 20.51%

Difficulty level: HARD

Depth of the landing basin: 0.3 m

- Users - height: min. 130cm; weight: min. 40 kg max. 130 kg.
- An absolute ban on a joint exit. Only a single exit is allowed.
- Only one person may be on the water slide launch pad.
- The only allowed downhill position is lying down straight with arms crossed over the chest, with legs in the direction of travel; this position should be maintained throughout the descent.
- After obtaining the permission of the lifeguard or service worker, you should:
 - calmly enter the cabin;
 - stand with your back to the wall;
 - take the right downhill position - straight with arms crossed on the chest;
 - calmly wait for the trapdoor to activate;
 - slide down freely without stopping in the gutter;
 - after completing the descent, immediately leave the landing area in the direction indicated by the arrows.
- Additionally, it is forbidden to:
 - open the cabin door;
 - perform a slide in pairs, in a group and with small children, especially those held in the arms on the stomach.

ad. II.

BLUE SLIDE

Slide data:

Length: 165.81 meters

Decrease: 8.92%

Difficulty level: AVERAGE

Depth of the landing basin: 0.3 m

- Users - height: min. 120 cm.
- A single descent on a single pontoon or a combined descent of two Users on a double pontoon is allowed. In the case of a descent on a double pontoon, each User must meet the above-mentioned requirements for the growth criterion.
- The descent takes place only on a pontoon intended for this purpose.
- The pontoon should be collected from the designated storage places and carried up the stairs to the slide's descent platform while maintaining extreme caution.
- Before descending, please check if there is water in the water slide tube. Dry descent is prohibited.
- Before descending, place the pontoon on the descending platform, take your place in it and wait for the green light to turn on.
- In order to start the descent, after the green light comes on, push off with your hands from the side walls of the water slide or the start bar. Slide freely without stopping in the tube of the water slide.
- Only one pontoon can be placed inside the downhill tube.
- The only permitted descent position is a sitting or semi-recumbent position with straight legs directed in the direction of travel and hands holding the pontoon handles. This position should be maintained throughout the descent.
- After the descent, immediately leave the braking basin in the direction indicated by the arrows, taking the pontoon with you.
- After the descent, the pontoon should be taken to the designated storage place.

ad. III.

GREEN PONTOON SLIDE

Slide data:

Length: 80.12 meters

Decrease: 17.12%

Difficulty level: HARD

Depth of the landing basin: 0.3 m

- Users - height: min. 120 cm.
- A single descent on a single pontoon or a combined descent of two Users on a double pontoon is allowed. In the case of a descent on a double pontoon, each User must meet the above-mentioned requirements for the growth criterion.
- The descent takes place only on a pontoon intended for this purpose.
- The pontoon should be collected from the designated storage places and carried up the stairs to the slide's descent platform while maintaining extreme caution.

- Before descending, please check if there is water in the water slide tube. Dry descent is prohibited.
- Before descending, place the pontoon on the descending platform, take your place in it and wait for the green light to turn on.
- In order to start the descent, after the green light comes on, push off with your hands from the side walls of the water slide or the start bar. Slide freely without stopping in the tube of the water slide.
- Only one pontoon can be placed inside the downhill tube.
- The only permitted descent position is a sitting or semi-recumbent position with straight legs directed in the direction of travel and hands holding the pontoon handles. This position should be maintained throughout the descent.
- After the descent, immediately leave the braking basin in the direction indicated by the arrows, taking the pontoon with you.
- After the descent, the pontoon should be taken to the designated storage place.

ad. IV.

FAMILY SLIDE

Slide data:

Length: 9.10m

Decrease: 7.11%

Difficulty level: EASY

Depth of the landing basin: 110 cm

- Users - height: min. 110 cm.
- Absolute prohibition of a joint exit. Only a single exit is allowed.
- Only one person may be on the water slide launch pad.
- Before descending, check that there is water in the downhill gutter. Dry descent is prohibited.
- The only allowed descent positions are:
 - stable sitting position with the face turned in the direction of travel, with straight legs and arms placed next to the body ;
 - lying on the back with straight legs, directed in the direction of travel and arms placed along the body.

The selected position must be maintained throughout the descent.

- After the descent, you must immediately leave the slide's landing site.
- Additionally, it is forbidden to:
 - perform a slide in pairs, in a group and with small children, especially those held in the arms on the stomach;
 - catch children under the slide;
 - dive under the slide.

ad. V

GUTTER SLIDE

Slide data:

Length: 9.10m

Decrease: 7.11%

Difficulty level: EASY

Depth of the landing basin: 110 cm

- Users - height: min. 110 cm.
 - Absolute prohibition of a joint exit. Only a single exit is allowed.
 - Only one person may be on the water slide launch pad.
 - Before descending, check that there is water in the downhill gutter. Dry descent is prohibited.
 - The only allowed descent positions are:
 - stable sitting position with the face turned in the direction of travel, with straight legs and arms placed next to the body;
 - lying on the back with straight legs, directed in the direction of travel and arms placed along the body.
- The selected position must be maintained throughout the descent.
- After the descent, you must immediately leave the slide's landing site.
 - Additionally, it is forbidden to:
 - perform a slide in pairs, in a group and with small children, especially those held in the arms on the stomach;
 - catch children under the slide;
 - dive under the slide.

§ 5

Regardless of the rules and restrictions described above, the Company stipulates that the Staff, for safety reasons, is entitled to refuse to use a given slide to persons who do not comply with the terms and conditions of their use, as well as to persons who, for other reasons, in a reasonable Personnel's opinion, should not use the slide in question.

§ 6

1. In the event of an accident caused by non-compliance with these Regulations, the User bears all responsibility.
2. All persons violating public order or the provisions of these Regulations will be removed from the slide and the pool area.
3. Other basic rules for using the Facility, as well as the rules of liability and obligations of the Customers, are regulated by the Regulations for using the swimming pool area and the main Regulations of the Facility.
