

**REGULATIONS FOR USING THE SPA BATHS
LOCATED IN THE AREA OF QUIET AND RELAXATION**

§ 1

1. These Regulations contain supplementary and special provisions specifying the rules for the use of the spa baths located in the area of quiet and relaxation in the swimming pool zone separated in the Chochółów Thermal Baths Facility.
2. Individual spa baths located in the area of quiet and relaxation are an integral part of the swimming pool zone and the above-mentioned area of quiet and relaxation, and all persons using them are obliged to comply with both the provisions of these Regulations and the Regulations for the use of the swimming pool zone and the Regulations for the use of the area of quiet and relaxation.
3. Each User is also obliged to strictly comply with the provisions of the main Regulations of the Facility.
4. In all matters not covered by these Regulations, the other Regulations in force in the Chochółów Thermal Baths Complex shall apply, particularly the provisions of the main Regulations of the Facility.
5. Each person using the spa baths is obliged to read these Regulations before using them and then comply with its provisions. It is also required to read the information boards available within the spa baths.

§ 2

1. The spa baths are available to Users entitled to use the swimming pool zone and the area of quiet and relaxation separated in this zone, in accordance with the rules in force in the above-mentioned zone and in the area of quiet and relaxation, taking into account the following reservations.
2. Using the spa baths is at the User's own risk.
3. People with circulatory, respiratory, neurological and gastric dysfunctions should use the spa baths with extreme caution and only after prior medical consultation.

§ 3

1. Use extreme caution when getting in and out of the spa baths.
2. The persons leaving the spa baths have priority in communication.
3. It is forbidden to cause situations that threaten one's own safety, the safety of other people using the spa baths and the swimming pool zone as well as the area of quiet and relaxation, or that may cause an accident, in particular:
 - entering and exiting the spa baths in a way other than through dedicated stairs/ladders;
 - using the spa baths when the aeration system is turned off;
 - using the spa baths if the access is closed with a chain, rope, barrier or other visible means;
 - pushing people into the spa baths;
 - bringing any objects into the spa baths, including bringing in and eating drinks or food, is prohibited;
 - staying in the spa baths in a standing position;
 - head and face immersion;
 - pouring water out of the spa baths;

- sitting on the rim of the spa baths.

4. All persons using the spa baths are obliged to strictly follow and comply with the instructions, commands and sound signals of lifeguards and employees of the swimming pool zone, as well as messages given through loudspeakers.

§ 4

1. In the event of an accident caused by non-compliance with these Regulations, the User bears all responsibility.

2. All persons violating public order or the provisions of these Regulations will be removed from the spa baths, as well as from the area of quiet and relaxation and the swimming pool zone.

3. Other basic rules for using the Facility as well as the rules of liability and obligations of the Customers are regulated by the Regulations for using the area of quiet and relaxation, the Regulations for using the swimming pool zone and the main Regulations of the Facility.
