REGULATIONS FOR USING THE INFRARED /TEXTILE/LOCATED IN THE AREA OF QUIET AND RELAXATION

- 1. These Regulations contain supplementary and specific provisions specifying the rules for using the textile infrared cabin (IR cabin), located in the area of quiet and relaxation in the swimming pool zone separated in the Chochołów Thermal Baths Facility.
- 2. The IR cabin located in the area of quiet and relaxation is an integral part of the swimming pool zone and the above-mentioned area of quiet and relaxation, and all persons using it are obliged to comply with both the provisions of these Regulations and the Regulations for the use of the swimming pool zone and the Regulations for the use of the area of quiet and relaxation.
- 3. Each User is also obliged to strictly comply with the provisions of the main Regulations of the Facility.
- 4. In all matters not covered by these Regulations, the other Regulations in force in the Chochołów Thermal Baths Complex shall apply, particularly the provisions of the main Regulations of the Facility.
- 5. Each person using the IR cabin is absolutely obliged to read the content of these Regulations before using them and comply with its provisions. It is also required to read the information boards available within the cabin.

§ 2

- 1. The IR cabin is available to Users entitled to use the swimming pool zone and the area of quiet and relaxation separated in this zone, in accordance with the rules in force in the abovementioned zone and in the area of quiet and relaxation, taking into account the following reservations.
- 2. The IR cabin is a dry sauna with a temperature of up to 60°C, air humidity of up to 15%, and an infrared heating system.
- 3. The IR cabin can only be used by healthy people or people whose ailments are not contraindications to using this type of sauna.
- 4. It is not recommended to use the IR cabin:
- people suffering from heart disease, hypertension and vascular diseases;
- people suffering from thyroid, claustrophobia, epilepsy, acute rheumatic conditions, cancer, acute infections and asthmatic conditions;
- people with fever;
- menstruating and pregnant women;
- people who are tired and intoxicated;
- people who are allergic or sensitive to essential oils.
- 5. The use of the IR cabin is at the User's own risk. The Company and its Management are not responsible for the health effects of staying in the sauna.

§ 3

- 1. Before entering the IR cabin room, you should:
- take care of your physiological needs;
- remove all metal objects (especially jewellery), as they may cause burns to the body;

- remove glasses and contact lenses (in the event of failure to comply with this requirement, the User must take into account the risk of damage to the glasses/contact lenses, for which the Company and its Management are not responsible if they occur);
- wash the whole body in the shower with soap and then wipe it dry;
- take off your pool shoes.
- 2. There may be a minimum of two people in the sauna.
- 3. In the IR cabin as a dry sauna, you should sit on a towel and keep your feet on it. The towel should be spread out so that no part of the body is in contact with the surface of the seat.
- 4. Any deterioration of well-being should be immediately reported to a staff member or lifeguard, or use the emergency button.
- 5. All persons using the IR cabin are obliged to strictly follow and comply with the instructions, commands and sound signals of lifeguards and employees of the swimming pool zone, as well as messages given through loudspeakers.

§ 4

- 1. In the event of an accident caused by non-compliance with these Regulations, the User bears all responsibility.
- 2. All persons violating public order or the provisions of these Regulations will be removed from the cabin, as well as from the area of quiet and relaxation and the swimming pool zone.
- 3. Other basic rules for using the Facility, as well as the rules of liability and obligations of the Customers, are regulated by the Regulations for using the area of quiet and relaxation, the Regulations for using the swimming pool zone and the main Regulations of the Facility.
