

## REGULATIONS FOR THE USE OF THE CHILD'S AREA

### § 1

1. These Regulations contain additional and specific provisions specifying the rules for using the children's area (hereinafter also referred to as the children's zone), located in the swimming pool area separated at the Chochołów Thermal Baths Facility.
2. The child's area is an integral part of the pool area, and all persons using it are obliged to comply with the provisions of these Regulations and the Regulations for using the pool area.
3. Each User is also obliged to strictly comply with the provisions of the main Regulations of the Facility.
4. In all matters not regulated in these Regulations, the provisions of the other Regulations applicable at the Chochołów Thermal Baths Complex shall apply, in particular, the provisions of the main Regulations of the Facility.

### § 2

1. Detailed rules for using individual parts, rooms, devices or attractions available in the children's zone, including parameters and limitations related to their use, are specified in separate regulations and may also be specified in instructions, information boards and pictograms. The above documents are available at the entrances to each place or attraction, and regulations and instructions are also available on the Facility's official website. Relevant information can also be obtained from the Staff.
2. Before using any attractions/devices/services, the child using them alone and/or the guardian of the child using them are obliged to read these Regulations, information boards, signs and instructions for use. It is necessary to understand the rules of use, analyse recommendations and contraindications to use, verify the health condition, and then comply with all applicable safety rules (guardians are obliged to convey the safety rules to the child and supervise their compliance). If you have any doubts, please ask the Staff for clarification.
3. It is prohibited to use individual zones and use attractions/devices contrary to the designated rules of their use, in particular by persons whose conditions and physical condition prevent safe use in accordance with the instructions (including the manufacturer's instructions).
4. Ultimately, each Guest, individually and on their own responsibility, makes an independent decision to use a given attraction/device/service available at the Facility, both for themselves and for the child under their care, taking into account any possible threats and risks associated with it.

### § 3

1. The basic restrictions on entry and use of the Facility, applicable to all Users, are specified in the provisions of the main Regulations of the Facility. The following rules only clarify them and in no way exclude the provisions of the main Regulations, which are also fully applicable to Users of the children's area.
2. The children's area is available to Users authorised to use the pool area, in accordance with the rules applicable in this area, taking into account the following reservations.

3. The children's area is available only to children up to 16 years of age who are under the constant care and supervision of a parent or authorised adult guardian (hereinafter referred to as the "guardian"), provided that for individual attractions/devices/services located in this area, Different age restrictions may apply, presented in the regulations/instructions/information boards.
4. Due to its nature and purpose, it is strictly forbidden to bring and consume any type of alcohol and alcoholic beverages in the child's area, including those purchased on the premises. It is also strictly forbidden to use the child's area (including entry to this area) by persons whose condition indicates that they have consumed alcohol or are under the influence of intoxicants or drugs or other substances with a similar effect, i.e. substances that disturb or limit the assessment of the situation or cause unnatural behaviour.

#### **§ 4**

1. Guardians are obliged to strictly and constantly supervise children when using the child's area and its water attractions, and either to stay in a place close to the water surface from which they can constantly see the child and be seen by him/her or to provide constant protection and stay in close proximity to the child – depending on the specific attraction (detailed requirements in this respect may be specified in the regulations/instructions/information boards for individual attractions/devices).
2. Guardians are responsible for children under their care, in particular for their safety, correct use of individual devices and attractions, and for any damage that may be caused. The duty of care cannot be transferred to other persons, in particular to the employees of Thermal Baths.
3. In a situation where children using the children's zone are left unattended, the thermal baths staff is entitled to inform their superiors about this fact and, in the event of a prolonged absence of guardians - to call officers of the appropriate services.
4. Participants of organised groups, including children and youth of school age, if they meet the criteria entitling them to use the child's area, may use the attractions, including water slides located in this area, only in the presence of the group's guardian supervising them. The guardian must be present and constantly supervise the group members, especially on the slide-starting platform.
5. Water attractions, particularly water slides located in the children's zone, are not intended for people with circulatory, respiratory, skeletal, neurological and gastric dysfunctions and those particularly sensitive to sudden overloads.

#### **§ 5**

1. When using the children's zone, including, in particular, the water slides located in this zone, it is prohibited to cause situations that threaten your own safety, the safety of other people using the child's area and the pool area, or that may cause an accident, in particular:
  - climbing on balustrades, handrails and structural elements not intended for this purpose;
  - entering and exiting individual attractions in a way other than dedicated steps/ladders;
  - using the child's area and its attractions if access is blocked with a chain, rope or other visible means;
  - adults who do not take care of children staying in the children's zone;
  - pushing and throwing children into the pool or slide;
  - jumping into the pool basin and sliding down the slide from a runway;

- starting the slide when there are already other Users in the landing area or within the slide area;
  - sliding in pairs, in groups and with small children, especially those held in their arms on their stomachs (if different rules apply, they will be specified in separate regulations/instructions/information boards for a given attraction);
  - sliding with objects that may cause bodily injury, in particular: glasses, jewellery (watches, rings and anklets, bracelets, thongs, chains, earrings, hair ornaments) and swimming equipment (boards, swimming goggles, etc.);
  - stopping while descending and getting up inside the slide;
  - staying in the landing area at the exit of the slide after completing the slide;
  - entering the slide from the end element side and climbing inside the slide towards the starting point.
  - regarding water basins located in the child's area, it is also prohibited to:
    - dive and jump into the water;
    - train apnea;
    - pour out water;
    - sit on the edge of the basin;
    - bring any items, including bringing and consuming drinks or food;
    - throw any objects into the water; dirty and pollute the basin; in particular, it is prohibited to meet physiological needs outside the toilet, pour cosmetic lotions into the water, etc.;
    - perform gymnastic exercises on ladders and handrails;
    - wear flip-flops or fins in the water.
2. Universal instructions for using slides located in the child's area:
- a) When entering the slide platform, be especially careful: running, pushing, forcing a place in the queue, etc., is prohibited.
  - b) Starting the slide is only allowed when there are no other Users on the landing area or in the area of the slide.
  - c) The slide takes place individually unless the regulations of a given slide clearly state otherwise.
  - d) Permitted slide positions are determined by the regulations of individual slides. In the absence of such regulations, it is assumed that the only permitted sliding position is a sitting position facing the direction of travel or lying on the back with legs together, straight, pointing in the direction of travel and arms placed along the body. This position must be maintained throughout the slide. Changing positions during the slide, as well as other sliding positions, are prohibited.
  - e) Rules of conduct during the slide:
    - calmly enter the starting section (pushing, running or leaning out is prohibited);
    - take the correct sliding position;
    - slide freely without stopping,
    - During the entire slide, observe the area in front of your feet so that if you encounter any predecessor of the slide, brake in time to avoid a collision;
    - after completing the slide, immediately leave the landing area at the exit of the slide;
    - Report any defects you may notice to the rescuer immediately after leaving the landing area.
3. All persons using the attractions in the children's zone, in particular the slides, are obliged to strictly follow and obey the instructions, commands and sound signals of lifeguards and pool area employees, as well as messages given by loudspeakers.

## **§ 6**

1. In the event of an accident caused by failure to comply with these Regulations, the User bears all liability.
2. All persons violating public order or the provisions of these Regulations will be removed from the child's area and the swimming pool area.
3. Other basic rules for using the Facility, as well as the rules of liability and obligations of Customers, are regulated in the Regulations for using the swimming pool area and the main Regulations of the Facility.
