

## **REGULATIONS FOR THE USE OF THE INTERNAL WATER PLAYGROUND LOCATED IN THE CHILD'S AREA**

### **§ 1**

1. These Regulations contain additional and specific provisions specifying the rules for the use of the internal water playground for children with water attractions located therein (hereinafter also collectively referred to as the "water playground"), located in the child's area in the swimming pool zone separated at the Chochołów Thermal Baths Facility.
2. The water playground located in the children's area and all water attractions constitute an integral part of the swimming pool area and the above-mentioned children's area. All persons using them are obliged to comply with the provisions of these Regulations, as well as the Regulations for using the swimming pool area and the Regulations for using the children's area. A child using the water playground and its attractions on their own and/or the guardian of a child using the water playground and its attractions are obliged to read these Regulations, information boards, signs and instructions for the use of water attractions before starting to use them and to convey the safety rules to the child (if applicable) and then follow their provisions.
3. Each User is also obliged to strictly comply with the provisions of the main Regulations of the Facility.
4. In all matters not regulated in these Regulations, the other Regulations applicable at the Chochołów Thermal Baths Complex shall apply, particularly the provisions of the main Regulations of the Facility.

### **§ 2**

1. Children under 13 may use the water playground only under the constant care and supervision of a parent or adult guardian. Guardians are obliged to strictly and constantly supervise children when using the water playground and its water attractions, and to stay in a place close to the water surface from which they can constantly see and be seen by the child. Leaving children unattended is strictly prohibited.
2. Participants in organised groups of school-age children and adolescents may use water attractions constituting part of the water playground only in the presence of a group guardian supervising them. The supervisor must be present and constantly supervise the group members.
3. Water attractions constituting part of the water playground are not intended for people with dysfunctions of the circulatory, respiratory, skeletal, neurological, and gastric systems, or those particularly sensitive to sudden overloads.

### **§ 3**

1. When using the water playground, you are prohibited from causing situations that threaten your own safety, the safety of other people using the water playground, the child's area and the swimming pool area, or that may cause an accident, in particular:
  - entering and climbing on devices, balustrades, handrails and structural elements not intended for this purpose;

- using the water playground and its attractions if access is closed with a chain, rope or other visible means;
  - using water playground devices and equipment in a manner contrary to their intended purpose;
  - adults who do not have custody of children staying in the water playground;
  - bringing and consuming any drinks or food into the area;
  - bringing any sharp or easily breakable objects into the area;
  - bringing in animals, bicycles, strollers, etc.;
  - pushing, hitting and using other forms of violence;
  - regarding water basins located on the playground, it is also prohibited to:
    - push others into the basin;
    - jump into the basin;
    - dive and jump into the water;
    - train apnea;
    - pour out water;
    - sit on the edge of the basin;
    - bring any items, including bringing and consuming drinks or food;
    - throw any objects into the water; dirty and pollute the basin; in particular, it is prohibited to meet physiological needs outside the toilet, pour cosmetic and chemical liquids into the water, etc.;
    - perform gymnastic exercises on ladders and handrails;
    - wear flip-flops or fins in the water.
2. The universal rules for using the slides located in the child's area are specified in the Regulations for using the child's area.
  3. When using water attractions or attractions with moving elements, each User is obliged to wear a swimsuit, and any hanging or loose clothing should be removed. Long hair, glasses and jewellery (watches, rings and wedding bands, bracelets, thongs, chains, beads, earrings, hair ornaments, etc.) must be removed because they may also pose a hazard, especially near the attraction's rotating equipment, and the hair is tied up or protected by wearing a bathing cap.
  4. All persons using the attractions of the water playground are obliged to strictly follow and obey the instructions, commands and sound signals of lifeguards and pool area employees, as well as messages given by loudspeakers. All cuts, injuries and various types of irregularities should be immediately reported to the lifeguard on duty.

#### **§ 4**

1. In the event of an accident caused by failure to comply with these Regulations, the User bears all liability.
2. All persons violating public order or the provisions of these Regulations will be removed from the water playground area, as well as from the children's area and the swimming pool area.
3. Other basic rules for using the Facility and the rules of responsibility and obligations of Customers are regulated by the Regulations for using the children's area, the Regulations for using the swimming pool area and the main Regulations of the Facility.
