## REGULATIONS SPECIFYING THE RULES FOR TAKING PHOTOS AND RECORDING VIDEOS AT THE CHOCHOŁÓW THERMAL BATHS FACILITY

§ 1

- 1. These Regulations contain additional and specific provisions specifying the rules for taking photos and recording videos at the Chochołów Thermal Baths Facility.
- 2. In all matters not regulated in these Regulations, the provisions of the other Regulations applicable at the Chochołów Thermal Baths Facility shall apply, in particular, the provisions of the main Regulations of the Facility. Each User is obliged to read the content of the above-mentioned documents and then to comply with their provisions.

§ 2

- 1. Taking photos and recording videos is allowed in all zones of the Facility except the sauna zone (where recording images or sound in any form is strictly prohibited) and only for private purposes.
- 2. Due to the specificity of the Facility's cash desks and the data and information collected there, it is also strictly forbidden to take photos and record videos directly at all cash registers located in the Chochołów Thermal Baths Facility (i.e. both the main ones and those located at the entrances to individual zones and areas of the Facility). The prohibition applies, in particular, to taking photographs/videos of cash register employees and their workstations.

§ 3

- 1. Each time, videos and photos should be taken in a manner that does not violate the personal rights of other Facility users, including the Company's Staff. In particular, recordings/photos must not violate every person's right to privacy, good name, confidentiality of conversation or correspondence, or be in any other way harmful to the person visible in the recording/photo.
- 2. Sharing and disseminating photos and recordings containing the image of a given person without obtaining his or her consent is prohibited.

§ 4

- 1. Professional recording of videos or taking photos may only occur after obtaining the Facility Management's prior consent.
- 2. The Company reserves that within the Complex, in particular during specific special events, photos/recordings may be taken by employees, representatives and other persons authorised by the Company or entities acting on behalf of the Company. In such situations, it is possible, in compliance with applicable legal provisions, that the image of individual persons using the Company's services may be recorded in photos, films or recordings, and then stored, processed and distributed by the Company for advertising, promotional, marketing information and reporting purposes, related to the Company's activities, in all known fields of operation, and in particular by publishing on the Company's websites, social networking sites used to promote the Company's activities (such as Facebook, Instagram, TikTok and others) and in all types of information and promotional materials, including both electronic and printed forms. Purchasing a ticket entitling to a given event and participating in such an event is tantamount to the Participant's free consent to the above, without time or territorial limits.

§ 5

- 1. In case of failure to comply with these Regulations, the User bears all liability.
- 2. Other basic rules for using the Facility, as well as the rules of responsibility and obligations of Customers, are regulated by the main Regulations of the Facility.
